For the above proceedings the laws of the following states were applied: Argentina, Austria, Belgium, Brazil, Congo, Czech, England, France, Georgia, Germany, Hungary, Iceland, India, Italia, Luxembourg, Norway, State of Ohio, Poland, Slovakia, South Africa, Spain, Switzerland, Turkey and two cases under "ex aequo et bono".
